

Secretary's Report for year 2016-17

Dear Members,

It gives me a great pleasure to welcome you to this 21st AGM of the Chapter. During this year, the Chapter has made healthy progress. In the Financial year 2016-17, Total **66** members were enrolled in different categories. From previous AGM of 2016 to this AGM, total **32** new members are enrolled which includes 12 Student members, 2 members, 7 Associate members and 11 Life Members.

Thus total registered members of SPE(I) Vadodara Chapter as on 31 July 2017 are 2300 out of which there are **535** Life Members.

It is my privilege to present before you the programmes arranged by SPE (I) Vadodara Chapter in 11 months during Sept-2016 to Jul-2017 i.e. from previous AGM to this AGM, as detailed below:

Chapter's Activities

(1) Chapter's Foundation Day:

On 03 Oct 2016, Chapter organised a Satyanarayan Pooja to celebrate the foundation day of the Chapter. The pooja, which was organized at the office premises of the Chapter, was well attended by members and their spouse. The pooja was performed by Er. SM Takalkar, Vice-Chairman of the Chapter and his better half Mrs. Purnima. The members and their family availed PRASAD and greeted each other.

(2) Power Day:

On 10 Nov 2016, the Chapter celebrated Power Day to commemorate the beginning of the electrical power system in India. A small Hydro Power Station was commissioned in Darjeeling on 10 Nov 1897. Er. HN Baxi, Executive Director, GSECL, Vadodara spoke on the topic of "Fuel Management in Thermal Power Plants". The speaker gave details of the sources and transportation of fuel and also cost effective fuel management in the era of Open Access and Power Trading. He also presented statistics of fuel and power generation in the state and the country.

(3) Energy Conservation Day:

On 10 Dec 2016, the Chapter celebrated Energy Conservation Day. Experts and exponents in the field of Energy Efficiency and Conservation were invited to give talk and present case studies.

Dr. Sagar Agrawat, Senior. Scientist, GERMI, Ahmedabad.

His presentation covered following:

- The Go I has an ambitious plan to add 1,00,000 MW Solar Power in to the Grid in next few years.
- If the total solar energy is tapped in reality, it is 1800 times more than the Global Power requirement.
- Direct utilization of solar energy includes mirror reflectors for cooking, special engines, power towers etc.
- He briefed about GERMI's flagship programs and commercial aspects of solar power generation.

Er. Bharatbhai V Shah, proprietor of M/s Poly-phase Motors, Vadodara had given his brief presentation in which, he stressed the need for energy efficient motors in every part of power utilization. He stated that large quantum of power/energy can be saved by utilizing energy efficient motors.

Er. JA Patel working with M/s Akaish Mechatronics Ltd., a company engaged in the business of Energy Audit.

He spoke on his personal experience in Energy Audit.

Er. KS Shah, Chief Manager (Elect.), GNFC, Bharuch.

His presentation covered the following.

- Various steps taken up by GNFC to conserve the energy
- Variable speed drives and their effect on energy saving.
- Use of high efficiency motors by GNFC
- Training to staff for energy conservation
- Use of LED for lighting and replacement of existing fans by 5-Star rated fans.
- Role of BEE in saving energy by introducing star rating
- Case study of replacement of 350kW motor by small motors and saving of 105kW.

Dr. BG Desai, an expert and exponent in the field of Energy Conservation, Audit and Management summed up the event.

The programme was designed by **Er. BN Raval, Executive Committee Member**.

(4) SWITCH EXPO - Govt. of Gujarat event by Federation of Gujarat Industries:

From 06 to 10 Oct 2016, Federation of Gujarat Industries planned SWITCH EXPO at Darjipura, Vadodara. Our Vadodara Chapter participated actively in this event by taking one STALL.
